2 Eligibility for Foreign Domestic Worker Levy Concession Rate of \$200 Per Month

An employer is eligible for low levy for each foreign domestic worker if he/she satisfies **Conditions A, B or C** below at the time of application for levy concession:

- A (i) the employer or spouse has a child who is a Singapore Citizen below 12 years old, and is living with him/her; or
 - (ii) the employer or spouse has a grandchild who is a Singapore Citizen below 12 years old, and is living with him/her; or
- B (i) the employer or co-residing spouse is a Singapore Citizen who is aged 65 years old or above; or
 - (ii) the employer or spouse is a Singapore Citizen and the other party is a Singapore Permanent Resident aged 65 years old or above, and both are living together at the same registered address as in NRIC; or
- C (i) the employer or spouse has a parent, parent-in-law, grandparent or grandparent-in-law who is a Singapore Citizen aged 65 years old or above, and is living with him/her at the same registered address as in NRIC; or
 - (ii) the employer is a Singapore Citizen and has a parent, parent-in-law, grandparent or grandparent-in-law who is a Singapore Permanent Resident aged 65 years old or above, and is living with him/her at the same registered address as in NRIC.

For each condition that is satisfied, the employer is eligible for levy concession for one foreign domestic worker. However, each household is only eligible for levy concession for a total of two foreign domestic workers at any one time.
